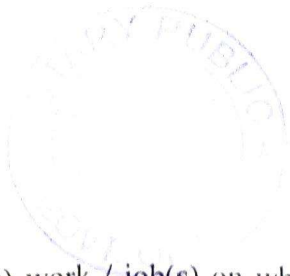
I, the above named deponent, do hereby solemnly affirm and declare as under:
